### TERMS & CONDITIONS

#### THE NORTHWEST GEORGIA BRIDAL SHOWCASE AGREES TO:

Conduct the Northwest Georgia Bridal Showcase on January 29, 2012 at The Forum from 1 PM to 5 PM.

Abide by our Rain or Shine Policy. In the event of severe weather conditions, the show will NOT be cancelled.

Provide the exhibitor with the booth package for which he/she pays for.

Advertise the show through various media.

Provide each paid exhibitor with a complete listing of all registered brides-to-be attending the show.

Include normal janitorial service, heating, air conditioning, and/or ventilation, normal utility and lighting services as provided by the facility under our control.

Furnish the brides-to-be with programs and promotional items on show day.

Provide ample time for set-up and teardown of booths.

RomeWeddings.com reserves the right to refuse any vendor for any reason.

RomeWeddings.com retains the right to change the location of the exhibitor's booth at any time at its sole discretion.

#### EXHIBITOR AGREES TO:

Full payment is required to reserve your booth along with your registration. Due to promotions and venue reservation, all registration payments include a \$100 non-refundable retainer-fee after 01/06/2012.

Exhibitors participate in the show at their own risk and can not hold Scott Productions, Inc., RomeWeddings.com, venue or show producers liable for damages, cost, losses, or expenses resulting from any incident connected with the showcase. The exhibitor is entirely responsible for the exhibit space allotted and shall be liable for any loss or damage to the premises and for any loss or damage to any equipment. Exhibitors must also carry their own business liability insurance.

Exhibitor agrees to exhibit only their own service. Booth sharing without prior consent will not be permitted and could result in expulsion from the show and/or a fine (booth cost) per violation. This includes business cards or other promotional items of other merchants, which may not be

displayed. If multiple representatives of the same company wish to share the booth space, this will be permitted. However, please notify show management prior to the show date.

Exhibitors will have the booth(s) manned during all show hours: 1:00 PM until 5:00 PM.

Exhibitors will not dismantle or breakdown booths until 5:00 PM.

Exhibitors will set-up booths between 8:00 AM and Noon on the day of the show.

Understand RomeWeddings.com has a No Outside Food or Beverage Policy. No alcohol will be permitted. However, sample size portions of food/drink are permitted and exhibitors must sign, submit, and abide by The Forum's Catering Policy.

Exhibitors shall exclusively use the given list of registered brides. Exhibitors will not lend-out, sell, barter or allow any unauthorized usage, or permit any reproduction thereof. Exhibitors who violate this policy and misuse the list will be banned from participating in future shows and subject to penalty fees.

Exhibitor agrees to provide a door prize for the drawings during the fashion show. The prize cannot be a discount, and must be free of any obligation to the winner.

Music and/or recordings must not interfere with the neighboring booths. Please be courteous of your fellow vendors and keep your sound at an appropriate level.
